Eligibility criteria:	Officials of Central Government, Central Public Sector Undertakings and Statutory and Autonomous bodies:-  (i) Holding equivalent post OR  (ii) Ten (10) years of regular service in the PB-1 Rs. 5200-20200+GP Rs.1900 (Under 6 <sup>th</sup> CPC) [Revised in Level-2 as per 7 <sup>th</sup> CPC] with working knowledge of computer.

2. The appointment will be made on deputation on foreign service terms and will be governed by the instructions issued by the DoP&Trg. OM No. 6/8/2009-Estt. (Pay II) dated 17<sup>th</sup> June, 2010, as amended from time to time. **The maximum age for appointment on deputation shall in no case exceed 56 years on the date of closing of application in TRAI.**
