The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

Officers holding the post having HAG scale i.e. Rs.67000-annual increment @3% 79000/- on regular basis or (ii) Officers in Senior Administrative Grade with three years of regular service in that grade or (iii) Group A officers having twenty one years of regular service in Group 'A' of which at least three years of regular service in the Senior Administrative Grade may also apply and in case of selection he/she may be considered for appointment as Principal Advisor in the HAG scale i.e. Rs.67000-annual increment @3% 79000/-.
