Sub: Calling applications for filling up the posts of Personal Assistant [PB-2 Rs. 9300-34800+Grade pay Rs.4200] and Stenographer (Hindi) [PB-1 Rs. 5200-20200+Grade Pay Rs. 2400] in TRAI (HQ), New Delhi on deputation on foreign service basis.
