The officer must possess the working knowledge of computer. <u>Essential:-</u> A Master/Bachelor's Degree in Business Administration /Economics/Commerce/Engineering/Law/ Science/ Humanities from a recognized University/ Institution or, Membership of the Institute of Chartered Accountants of India/ Institute of Cost and Works Accountants of India and possessing requisite experience in the relevant field. <u>Age:-</u> Not exceeding 56 years on the date of closing of applications.

2. The post has been exempted from the rule of immediate absorption upto 23.05.2013 by Department of Pension & Pensioners Welfare for appointment of central Govt. servants on deputation
