3. The posts of Deputy Advisor/Joint Advisor have been exempted upto 23.1.2016 from the rule of immediate absorption by Department of Pension & Pensioners Welfare for appointment of central govt., servants on deputation.

All the Ministries/Departments, Public Sector Undertakings and Statutory and Autonomous Bodies are requested to forward applications in the prescribed proforma (can be downloaded from TRAI website www.trai.gov.in) alongwith attested copies of ACRs for the last five years and vigilance/disciplinary clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately in the event of their selection.
