## **Telecom Regulatory Authority of India**

TRAI Releases Report on Independent Drive Test conducted in Mumbai Service area from 10<sup>th</sup> to 13<sup>th</sup> May 2016.

**New Delhi 21<sup>st</sup> June, 2016:** TRAI conducts Audit and assessment of Quality of Service being provided by service providers through independent agencies for Cellular Mobile Telephone Service, Basic Service and Broadband Services.

As a part of this audit, the Audit Agency M/s IMRB International has carried out Independent Drive Test for Cellular Mobile Telephone services in Mumbai service area, from 10<sup>th</sup> to 13th May, 2016 covering various locations in the Mumbai service area. The performance of Airtel, Aircel, Idea, Vodafone, Reliance, MTNL and TATA and has been measured across various technologies (2G, 3G and CDMA). The drive test was conducted over a distance of 580 k.m. The test results obtained from these drive tests were used to assess the network condition more specifically in terms of Radio Frequency (RF) Coverage; Rx Quality; Call Setup Success Rate; Call Drop; Voice Quality; Blocked calls; and Carrier to Interference ratio. The summary of the Service Provider's performance on the key parameters based on Independent Drive Test is given here under:-

- 2. The salient findings of the independent drive test are as under:-
  - Most of the operators have met the Call Setup Success Rate benchmark of >= 95% except MTNL 2G & 3G and RCOM 2G.
  - Most of the operators have met the Call Blocked Rate benchmark of <= 3% except Airtel 2G, MTNL 2G & 3G and RCOM 2G & CDMA.
  - Most of the operators are not meeting the Call Drop Rate benchmark of <= 2% expect Airtel 2G & 3G and Vodafone 2G.</li>
  - Airtel 2G & 3G, MTNL 3G, Tata 2G, and Vodafone 2G & 3G have met the Rx Quality Rate benchmark of >= 95%. On the other hand Aircel 2G, Idea 2G, MTNL 2G, RCOM 2G & CDMA and Tata CDMA failed to achieve Benchmark.
